Total Sales \$350.00 NWCA's Commission \$52.50 BSG booth cost \$245.00 The traffic seemed more than last year however folks were not buying. In talking with other vendors they commented that sales were down.

Oregon State Fair for 2024 will have a Cashmere goat show. Ron suggested we have a board meeting at the same time. Current board agreed.

Ron noticed at OFFF they have a miscellaneous fiber class and suggested folks enter in their cashmere fiber that is not needed for the goat show.

Goat Show at OFFF

In 2024 Lyn Powell will beheading up the goat show with Jamie as the backup/support.

In 2024 need to make sure we have the same classes for does as there are for bucks. Does are missing show champion.

Questions to ask OFFF's board

Lyn/Jamie will ask the OFFF to increase judge compensation to cover 2 nights of motel, instead of just one. We need to define 'Breeder's trio'. Question should they be the same as the rules for the Oregon State Fair. Ask OFFF if the rules for having a goat show and Breeder's trio can be the same as the Oregon State Fair State Fair you need 3 farms and 15 goats to have a show. OFFF's rules are 5 farms and 25 goats.

Out reach – Lyn Powell

Fleece competition for 2024 is in our court. Jyane Deardorff is willing to be both the fleece and cashmere goat show judge.
